

VICTORIAN ENVIRONMENTAL WATER HOLDER
SEASONAL WATERING STATEMENT #1 FOR
GOULBURN BROKEN CATCHMENT MANAGEMENT AUTHORITY 2018-19
LOWER BROKEN CREEK

The Victorian Environmental Water Holder makes the following seasonal watering statement under section 33DY of the *Water Act 1989*.

1. PURPOSE

This seasonal watering statement authorises Goulburn Broken Catchment Management Authority to use water from the Water Holdings to maintain water quality, increase the native fish population and control *Azolla* build-up in the lower Broken Creek, consistent with the *Seasonal Watering Plan 2018-19*. This seasonal watering statement also authorises use of return flows from the lower Broken Creek at downstream sites along the River Murray.

2. DURATION OF APPROVAL

This seasonal watering statement is valid from 1 July 2018 to 30 June 2019, unless superseded by another seasonal watering statement or revoked by the Victorian Environmental Water Holder.

3. AUTHORISATION TO USE THE WATER HOLDINGS

Goulburn Broken Catchment Management Authority is authorised to use up to 50,000 ML of water from the Water Holdings in lower Broken Creek.

This water is made available by the Commonwealth Environmental Water Holder and can be used under the *Bulk Entitlement (River Murray – Flora and Fauna) Conversion Order 1999* (ABA094003) and the *Goulburn River Environmental Entitlement 2010* (ABA094000) held by the Victorian Environmental Water Holder.

This authorisation is made in accordance with a decision by the Commonwealth Environmental Water Holder communicated through the *CEWO Watering Schedule – Lower Broken Creek 2018-19 to 2022-23*, executed on 21 June 2018.

Water is to be delivered consistent with the potential watering actions specified in section 5.5.2 of the *Seasonal Watering Plan 2018-19* and the provisions of the entitlement.

This authorisation is subject to:

- (a) consultation with Victorian Environmental Water Holder to ensure the availability of sufficient water in the Water Holdings to which this statement applies and the appropriate allocation bank account to order water from
- (b) implementation of the risk mitigating strategies identified in Goulburn Broken Catchment Management Authority's *Lower Broken Creek Seasonal Watering Proposal 2018-2019* and in line with section 1.3.6 of the *Seasonal Watering Plan 2018-19*
- (c) reporting to the Victorian Environmental Water Holder on implementation of this seasonal watering statement in accordance with the *Guidelines for reporting on the management of the Water Holdings*.
