

**VICTORIAN ENVIRONMENTAL WATER HOLDER**  
**SEASONAL WATERING STATEMENT #3 FOR**  
**MALLEE CATCHMENT MANAGEMENT AUTHORITY 2022-23**  
**HATTAH LAKES**

The Victorian Environmental Water Holder makes the following seasonal watering statement under section 33DY of the *Water Act 1989*.

**1. PURPOSE**

This seasonal watering statement authorises Mallee Catchment Management Authority to use water from the Water Holdings in Hattah Lakes to achieve environmental objectives and expected water effects specified in section 5.2.5 of the *Seasonal Watering Plan 2022-23* and for emergency environmental watering in accordance with section 1.3.7 of the *Seasonal Watering Plan 2022-23*. This seasonal watering statement also authorises the use of return flows from Hattah Lakes at downstream sites along the Murray River.

**2. DURATION OF APPROVAL**

This seasonal watering statement is valid from 9 August 2022 to 30 June 2023, unless superseded by another seasonal watering statement or revoked by the Victorian Environmental Water Holder.

**3. AUTHORISATION TO USE THE WATER HOLDINGS**

Mallee Catchment Management Authority is authorised to use up to 35,000 ML of water from the Water Holdings at Hattah Lakes.

This water is made available by the Victorian Environmental Water Holder and the Commonwealth Environmental Water Holder and can be used under the *Bulk Entitlement (River Murray – Flora and Fauna) Conversion Order 1999* (allocation accounts 043265, 094002, 068158, 068154, 108632, 108633, 108634, 043408, 107193, 062294, 065283 and 065905) held by the Victorian Environmental Water Holder.

This authorisation includes water committed:

- by the Commonwealth Environmental Water Holder in accordance with the *Commonwealth Watering Schedule – 2022-23 Hattah Lakes* executed on 8 August 2022
- in accordance with a decision of the Southern Connected Basin Environmental Watering Committee communicated to the Victorian Environmental Water Holder via an email sent on 28 June 2022
- by the Victorian Environmental Water Holder.

Water is to be delivered under the provisions of the entitlement and in accordance with Table 5.2.12 of the *Seasonal Watering Plan 2022-23* or the emergency watering procedure in section 1.3.7 of the *Seasonal Watering Plan 2022-23*.

This authorisation is subject to:

- (a) consultation with Victorian Environmental Water Holder to ensure the availability of sufficient water in the Water Holdings to which this statement applies and the appropriate allocation account to order water from
- (b) consultation with the Victorian Environmental Water Holder when undertaking emergency environmental watering

- (c) implementation of the risk mitigating strategies identified in Mallee Catchment Management Authority's *Seasonal Watering Proposal 2022-23 Hattah Lakes* and in line with section 1.3.6 of the *Seasonal Watering Plan 2022-23*
- (d) reporting to the Victorian Environmental Water Holder on implementation of this seasonal watering statement.
