VICTORIAN ENVIRONMENTAL WATER HOLDER SEASONAL WATERING STATEMENT #4 FOR GOULBURN BROKEN CATCHMENT MANAGEMENT AUTHORITY 2024-25 GOULBURN RIVER

The Victorian Environmental Water Holder makes the following seasonal watering statement under section 33DY of the *Water Act 1989*.

1. PURPOSE

This seasonal watering statement authorises Goulburn Broken Catchment Management Authority to use water from the Water Holdings in the Goulburn River to achieve environmental objectives and expected watering effects specified in section 5.4.1 of the Seasonal Watering Plan 2024-25 and for emergency environmental watering in accordance with section 1.2.8 of the Seasonal Watering Plan 2024-25.

2. DURATION OF APPROVAL

This seasonal watering statement is valid from 1 July 2024 to 30 June 2025, unless superseded by another seasonal watering statement or revoked by the Victorian Environmental Water Holder.

3. AUTHORISATION TO USE THE WATER HOLDINGS

Goulburn Broken Catchment Management Authority is authorised to use up to 380,000 ML of water from the Water Holdings in the Goulburn River.

This water is made available by the Victorian Environmental Water Holder and the Commonwealth Environmental Water Holder and can be used under the *Goulburn River Environmental Entitlement* 2010 (allocation accounts 093999, 094000, 108627, 108628) held by the Victorian Environmental Water Holder.

This authorisation includes water committed:

- By the Commonwealth Environmental Water Holder in accordance with a decision communicated through the CEWH-VEWH Watering Schedule Goulburn River system for 2024-25 to 2027-28 executed on 25 June 2024.
- By the Victorian Environmental Water Holder.

Water is to be delivered under the provisions of the entitlement and in accordance with the potential environmental watering actions specified in Table 5.4.1 of the Seasonal Watering Plan 2024-25 or the emergency watering procedure in section 1.2.8 of the Seasonal Watering Plan 2024-25. The potential watering actions authorised are those that are denoted as tier 1 in Table 5.4.2 of the Seasonal Watering Plan 2024-25.

This authorisation is subject to:

- (a) consultation with Victorian Environmental Water Holder to ensure the availability of sufficient water in the Water Holdings to which this statement applies and the appropriate allocation account to order water from
- (b) consultation with the Victorian Environmental Water Holder when undertaking emergency environmental watering
- (c) implementation of the risk mitigating strategies identified in Goulburn Broken Catchment Management Authority's Seasonal Watering Proposal Goulburn River 2024-25 and in line with section 1.2.7 of the Seasonal Watering Plan 2024-25
- (d) reporting to the Victorian Environmental Water Holder on implementation of this seasonal watering statement.
