

VICTORIAN ENVIRONMENTAL WATER HOLDER
SEASONAL WATERING STATEMENT #2A FOR
NORTH EAST CATCHMENT MANAGEMENT AUTHORITY 2024-25

UPPER MURRAY WETLANDS: RYANS LAGOON 1 AND RYANS LAGOON 2

The Victorian Environmental Water Holder makes the following seasonal watering statement under section 33DY of the *Water Act 1989*.

1. PURPOSE

This seasonal watering statement authorises North East Catchment Management Authority to use water from the Water Holdings at Ryans Lagoon 1 and Ryans Lagoon 2 to achieve environmental objectives and expected watering effects specified in section 5.2.1 of the *Seasonal Watering Plan 2024-25* and for emergency environmental watering in accordance with section 1.2.8 of the *Seasonal Watering Plan 2024-25*.

2. DURATION OF APPROVAL

This seasonal watering statement is valid from 11 November 2024 to 30 June 2025, unless superseded by another seasonal watering statement or revoked by the Victorian Environmental Water Holder.

3. AUTHORISATION TO USE THE WATER HOLDINGS

North East Catchment Management Authority is authorised to use up to 200 ML of water from the Water Holdings in Ryans Lagoon 1 and Ryans Lagoon 2.

This water is made available by the Commonwealth Environmental Water Holder and can be used under the *Bulk Entitlement (River Murray – Flora and Fauna) Conversion Order 1999* (allocation account 094003) held by the Victorian Environmental Water Holder.

This authorisation includes water committed by the Commonwealth Environmental Water Holder in accordance with a decision communicated through the *Commonwealth Watering Schedule – 2024-25 Victorian Upper Murray Wetlands*, executed on 3 September 2024.

Water is to be delivered under the provisions of the entitlement and in accordance with the potential environmental watering actions specified in Table 5.2.1 of the *Seasonal Watering Plan 2024-25* or the emergency watering procedure in section 1.2.8 of the *Seasonal Watering Plan 2024-25*.

This seasonal watering statement supersedes *Seasonal Watering Statement #2 for North East Catchment Management Authority 2024-25* and the total volume authorised includes water used under that seasonal watering statement between 4 September 2024 and 10 November 2024.

This authorisation is subject to:

- (a) consultation with Victorian Environmental Water Holder to ensure the availability of sufficient water in the Water Holdings to which this statement applies and the appropriate allocation account to order water from
- (b) consultation with the Victorian Environmental Water Holder when undertaking emergency environmental watering
- (c) endorsement of a delivery plan for Ryans Lagoon 1 and Ryans Lagoon 2 by the Victorian Environmental Water Holder and implementation of the conditions and risk mitigating strategies of the endorsed delivery plan and in line with section 1.2.7 of the *Seasonal Watering Plan 2024-25*

- (d) confirmation by the Victorian Environmental Water Holder that the costs of the watering action/s to which this statement applies can be supported.
- (e) reporting to the Victorian Environmental Water Holder on implementation of this seasonal watering statement.
